The General Teaching Council for Northern Ireland (GTCNI) is the professional and regulatory body for teachers in Northern Ireland. Their role includes registering teachers, maintaining professional standards, and ensuring schools have access to a high-quality workforce.

Challenge

GTCNI needed to overhaul its teacher registration system, transitioning from manual data entry to a modern, self-service digital platform. The previous system required GTCNI staff to manually input applicant data, a time-consuming process prone to inefficiencies. This project aimed to digitise the system for teacher registration, allowing prospective teachers to apply online, upload required documents, and track their applications in real-time. Additionally, GTCNI sought to provide registered teachers with a platform to update their profiles and submit applications, as well as empower schools and the general public with specific access to the teacher register.



Solution

Fortesium delivered a comprehensive digital solution, *Regulator Online*, tailored to meet GTCNI's unique needs. Key features of the solution included:

- A self-service portal for new applicants to register, upload necessary documentation, and track their application from submission to approval.
- A dedicated platform for registered teachers to manage personal profiles and submit certification applications.
- The GTCNI School Portal, allowing schools to check teacher employment eligibility, update records, and submit professional development certificates.
- A public-facing "Search the Register" tool, enabling easy access to teacher information.
